## **COUNT ONE**

DO FIND AND PRESENT, that **LEON DUPREE CAMPBELL** on or about the 26th day of February, 2020, in the County of Summit and State of Ohio aforesaid, did commit the crime of **POSSESSION OF A FENTANYL-RELATED COMPOUND** in that he did knowingly obtain, possess, or use a controlled substance or a controlled substance analog and and the drug involved in the violation was a fentanyl-related compound and neither division (C)(9)(a) nor division (C)(10)(a) of Section 2925.11 of the Revised Code applies to the drug involved, or was a compound, mixture, preparation, or substance that contained a fentanyl-related compound or was a combination of a fentanyl-related compound and another controlled substance and neither division (C)(9)(a) nor division (C)(10)(a) of this section applies to the drug involved and the amount of the drug involved equals or exceeds one gram but is less than five grams, in violation of Section 2925.11(A), 2925.11(C)(11)(b) of the Ohio Revised Code, a FELONY OF THE FOURTH DEGREE, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

## COUNT TWO

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **LEON DUPREE CAMPBELL** on or about the 26th day of February, 2020, in the County of Summit and State of Ohio aforesaid, did commit the crime of **AGGRAVATED POSSESSION OF DRUGS** in that he did knowingly obtain, possess, or use a controlled substance or a controlled substance analog and the drug involved in the violation is a compound, mixture, preparation, or substance included in Schedule I or II, to wit: methamphetamine, a Schedule II drug, in violation of Section 2925.11(A), 2925.11(C)(1)(a) of the Ohio Revised Code, a FELONY OF THE FIFTH DEGREE, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.
