INDICTMENT for POSSESSION OF A FENTANYL-RELATED COMPOUND-2925.11(A)(C)(11)(B)-F4; AGGRAVATED POSSESSION OF DRUGS-2925.11(A)(C)(1)(A)-F5

On March 18, 2020, S. Benjamin Carro, the Assistant Prosecuting Attorney appeared on behalf of the State of Ohio. The Defendant appeared before the Court with Attorney Andrea Whitaker, standing in with the Defendant's consent for James K. Reed, who was appointed, and being arraigned on said indictment, the reading thereof having been waived, enters a plea of "NOT GUILTY" to the charges therein.

The bond as previously set in Municipal Court is **amended** to a statutory Release on Defendant's Own Recognizance pursuant to Ohio Revised Code Section 2937.29, with maximum pretrial supervision, including urine drug screens, and the Defendant shall comply with all terms and conditions of the Summit County Pretrial Supervision Program Conditions of Release. A failure to appear as required by Recognizance shall constitute an offense subject to the penalty provided in Ohio Revised Code Section 2937.99.

All bond documents shall be transferred to the Summit County Clerk of Courts for Common Pleas, and that all previous conditions of remaining on bond from Municipal Court are in full force and effect and are to remain so until terminated by the assigned Common Pleas Judge.

As a further condition of bond herein, the defendant is ordered to report to 750 West Market Street by 1:00 P.M. the following business day after he is released.

IT IS ORDERED that this case be assigned to JUDGE MICHAEL with a pretrial set for April 22, 2020 at 9:00 A.M.

If a BCI report is required for use by either the State or Defense, such report shall be ordered forthwith by whichever party anticipates its use.

The Defendant is remanded to the Summit County Jail, and is NOT TO BE RELEASED due to emergency jail overcrowding due to the **holder** placed by the Adult Parole Authority, until further order of the assigned Judge.
